# 7 Site Secretary Report GKC (circulated)

# Tenancies and Waiting List: actions since last meeting on 10 September 2019

MMK is handling Lettings and will report. We have had one confirmed voluntary termination since 10 September (the plot has been re-let), with another expected shortly. As of 6 November 2019 there are no vacant plots on site and 151 entries on the Waiting List (up 6 since last meeting) with 10 new applications since September 10 (continuing the late summer rush). Despite the long waiting list, the most recent people reaching the top of the list are still only waiting 29 months before being offered a viewing.

### **2019 Plot Inspections**

It has been confirmed that there will be no second inspection by the Allotment Coordinator in 2019 due to lack of time. However problem plots can be reviewed individually if necessary.

### Haringey Issue of NCNs for Non-Payment of Invoices

A recurrent complaint at the quarterly public Haringey Allotment Forum meetings over recent years has been the incorrect issuing of demands for plot rental payment by Haringey to tenants who have already paid. GKC put this forward for the Agenda of recent HAF meetings where it was discussed and a plan for improvement agreed, which will be put into action in 2020.

### Site Mowing

GKC has continued mowing the lanes and main paths, plus the picnic area and orchard.

#### Hire of HAA Equipment

Hire of the strimmer, mowers and the chipper continue by arrangement.

### **Proposed Container Area**

GKC has buried the plastic conduit underground within a large scaffolding pole (found on site) in case of later adding of mains power from the street. Next step is to lay the weed fabric (in Shed Shop). We have some stock of cement in the Shed Shop but will still need to order in a large bag of sand and perhaps some more cement in order to prepare the base. Once the area is paved we can proceed with purchase of the flatpack shed and assembly.
